I hereby wish to apply for a temporary residence permit for the purpose described above. I confirm that the details provided above and below are, to the best of my knowledge, correct and complete.

Notes, instructions and data privacy agreement:

I have been made aware of the following points:

1. In accordance with Section 55 Paragraph 1 and Paragraph 2 No. 1 of the German Residence Act (AufenthG), a foreigner in Germany or abroad may be expelled if they, as part of an administrative procedure carried out by the authorities of a state in which the Schengen Implementation Convention applies, provide incorrect or incomplete details for the purpose of obtaining a German residence title, a Schengen visa, a replacement passport, permission to be excluded from the requirement to hold a passport or to defer deportation, or, in spite of their legal duty to do so, fail to cooperate with measures taken by the authorities responsible for ensuring that this Act or the Schengen Implementation Convention is applied.

2. In accordance with Section 95 Paragraph 2 No. 2 of the German Residence Act (AufenthG), a person who provides or uses incorrect or incomplete details in order to obtain for themselves or another person a residence title or knowingly uses an official document obtained in this way for fraudulent purposes may face up to three years' imprisonment or a fine.

3. In accordance with Section 82 Paragraph 1 of the German Residence Act (AufenthG), the foreigner must promptly assert their interests and any circumstances in their favour which are not obvious or not known by providing details of verifiable circumstances, and must promptly supply the necessary evidence of their personal circumstances, any other necessary certificates and permits as well as any other necessary proof which they may have in their possession.

4. The details requested in the application form are based on the German Residence Act (AufenthG). Given the large number of regulations in force, the immigration authority can provide details of the basic legal conditions which apply in each individual case.

5. The information under no. 6, 9, 10 and 22 are optional. As far as you provide information there, you grant the Aliens Authority permission to collect, process and use this data. The purpose of collecting, processing and using this data is their use in aliens law proceedings. If you refuse to provide information there, in individual cases this may result in disadvantages for the applicant. Please take notice of no. 3 above.
